- ii. Men's Jail (Jack M) [Thursdays @7:00p]
 - Not present.
- iii. Orange Street (Carol) [Tuesdays @ 7:30p]
 - Same as women's jail. Said she will reach out this week for a status.
- iv. Valley Epic (Juli B) [Tuesdays @ 8:00p]
 - Not allowing people in. Suggests we wait to follow up with facilities once we know the state is lifting the restrictions.
- v. Men's Prison (Nate) [Sundays @ 7:00p]
 - Not present. Larry gave report (I think). He said they are letting lots of people out (I believe). If he said any more than that I missed it, sorry.
- vi. Women's Prison (Carol) [Friday @ 7:00p]
 - Will send an email for status this week.
- vii. SL Behavioral (Jeremy F) [Fridays @ 6:30p]
 - Not present. But messaged me his report: "I just wanted to report that I
 am still going to Salt Lake Behavioral Health every Friday night. They do
 not allow visitors, but they are letting me come. So as long as I am not
 sick, I will keep going."
- viii. VA (Larry C) [Mondays @ 3:00p]
 - Very strict, won't let anyone in. Pointed out that he personally will be the last to start going outside because of his age and health.
- ix. Odyssey House (Ruth) [Wednesdays @ 12:45p]
 - Not present. Carol said Ruth is not doing it now, Sarah H, who works
 there, is running the meeting on Fridays now. Stephanie asked about if
 this is technically fine, we agreed not normally but under the
 circumstances. Sarah then joined the call, Carol asked about this
 concern and Sarah said she does believe their intention is to go back to
 the way it was as soon as we can.
- x. VOA (Rod F) [Tuesdays @ 7:00p]
 - Not present. Someone (Larry?) said it's locked down as well and are very afraid of the results once restrictions are lifted.
- xi. Recovery Ways (Stephanie E) [Tuesdays @ 7:00p]
 - Said they will reach out when they start to let people come in again. Asked about offering Zoom meetings for them. Amanda said she was going to bring up in new business. Stephanie also pointed out she will be one of the last to start going outside again even when the restrictions are lifted because she is immune compromised.
- xii. Fred House (Larry C) [Tuesdays from 9:30a-11:30a]
 - Lots of people being released from prison.
