 - Going great, thanks to Ruth for all her help. Definitely need more help on Mondays.
- ii. Men's Jail (Jack M) [Thursdays @7:00p]
 - Could use more members.
- iii. Orange Street (Carol) [Tuesdays @ 7:30p]
 - Doing well. Only 2 people last week, usually between 5-10 people.
- iv. Valley Epic (Juli B) [Tuesdays @ 8:00p]
 - Going well, steady attendance, tries to bring in speakers regularly.
- v. Men's Prison (Nate) [Sundays @ 7:00p]
 - 7 guys badged to go in currently. The residents would like a mid-week meeting. If we had more people, we could have another meeting. Larry said also they have asked for meeting on the mainline (not already treatment line). Need maybe 3 more people in order to facilitate that.
- vi. Women's Prison (Carol) [Friday @ 7:00p]
 - Going splendidly. Not a lot of people coming to it, about 2-3 people only.
- vii. SL Behavioral (Jeremy F) [Fridays @ 6:30p]
 - Not present.
- viii. VA (Larry C) [Mondays @ 3:00p]
 - Small meeting because it's on the acute psychiatric side (most current residents). If we got more people, we could go upstairs which has more recovered and willing residence. Keep in mind that it takes a long time to get approved.

 - Good speakers lately. She will be gone for 2 weeks this month; Cassidy
 will take over those 2 weeks. She said the residence really want key
 tags. Amanda said we generally don't do this because we would be
 spending a lot of money on key-tags since treatment facilities generally
 have a high turnover rate. She said that Orange Street gives them out,

and Carol said because they buy their own. Larry said he has about a thousand dog tags and to talk to him after.
