  - Going every other week unless there is a holiday. Nate backed out for personal reasons, and Larry can't go for health reasons. Mostly men, a couple women show up. Ruth asked for clean time requirement, Carol advised 6 months. Ruth wants to start getting cleared for it.

  - Not present, no report.
- x. VOA (Joey L) [Tuesdays @ 7:00p]
  - Joey/Donald 1st week, Jack 2nd week, Ryan 3rd week, James H 4th week (and 5th week if there happens to be one). Joey said usually about 6-10 guys present. Jack stated he is concerned that the 12 traditions is in the box, and he says they aren't supposed to be read at H&I meetings. He also said the Just for Today reading is missing.
